SELLER'S AGREEMENT

Return Seller's Agreement and Registration Form to a Member Service Center by 5:00p.m. June 5!

I, _____, **the owner of this vehicle, do hereby acknowledge and agree to abide by, the following:**

1. To prominently display on my vehicle, the Sale Sheet given to me by BHFCU the day of the event;
2. To stay with my vehicle at all times while it is being displayed. All negotiations regarding my vehicle are my responsibility;
3. To have my vehicle at the sale between 7:00 and 7:45 am. I understand that no vehicles will be allowed in the lot before the sale date and time;
4. To comply with parking and traffic flow guidelines;
5. To remove my vehicle promptly after the sale; and
6. To observe the registration limit of one vehicle per member.

BE ADVISED THAT BHFCU IS NOT A VEHICLE DEALER:

Owners are responsible for the display of their vehicles. Black Hills Federal Credit Union provides only the space to display vehicles and is not taking any vehicles on consignment for sale. Sellers must stay with their vehicles at all times during the sale and will deal directly with buyers concerning price, test drives and final sale agreements. Negotiations for sale and financing arrangements are between the buyer and seller. BHFCU will advertise the sale but will not perform sales, brokerage or solicitation functions for other parties. Members are encouraged to sell their vehicle at our sale with no commissions, no fees, and no additional charges.

I agree that BHFCU is not liable for any injuries, claims, damages, losses, expenses, or fees that may occur as a result of my participation in the Member Auto Sale. Participants in the Member Auto Sale must be 18 years of age or older at the time of registration.
